NO PICK UPS FROM HOME

Any Health Solutions client can ride the shuttle to and from their appointment at a Health Solutions location free of charge.

Clients must call C2C at (719) 545-2746 two hours in advance to verify their appointment before calling to schedule a shuttle pickup.

Pickups and drop-offs outside of this schedule for Youth and Family Services, Chinook, Recovery Solutions, The Learning Center or The Family Center may be possible. Please contact the appropriate shuttle driver with these requests.

Clients needing a shuttle from 41 Montebello Rd. (Montebello Office) after 6:00pm are asked to sign in on the Shuttle clipboard at the Crestone Recovery Center's reception desk located in the lower level of the Montebello office. Please see the Crestone front desk.

Health Solutions Shuttle Service Guidelines

Please Read!

All passengers must wear a seat belt while on the shuttle.

Physical or verbal aggression toward the driver or passengers will not be tolerated and may result in asking the individual to get off at the next safe location.

Furthermore, he or she may not be allowed to ride the shuttle in the future.

No smoking (cigarettes, e-cigarettes or vaping products) or chewing tobacco is allowed on the shuttle.

No alcohol, illegal drugs, or weapons are allowed on the shuttle.

No food or drinks (except bottled water) are allowed on the shuttle.

No bicycles are allowed on the shuttle.

Personal belongings left on the shuttle and found by the driver may be picked up at the Crestone Recovery Center's reception desk in the lower level of the Montebello office.

If a Health Solutions client suffers a medical emergency, the driver will pull over at a safe location and call 911.

Individuals with a wheelchair cannot be transported in a Health Solutions Shuttle, as they are not equipped with wheelchair access.

A parent/guardian must accompany children, 16 yrs. old or under on the shuttle.

Parent/guardian must provide appropriate child-safety seat(s) for the child(ren).

Shuttle drivers do not call anyone to announce their arrival at any location. It is the Health Solutions client's responsibility to watch for the shuttle.

Evening Shuttle Services: As the transit station closes at 5:30pm, clients will be dropped off at a well-lit public location within Pueblo city limits as close to their home as possible. The driver will **NOT** be able to drop off clients at their homes.
